### **Key Issues:**

### What top three points can you distill from community input to take to DFO RHQ?

- 1. Activities by CN line crews removing beaver dams upstream continue to have a major impact on salmonids in the watershed. Despite assurances given in two years of roundtable discussions, crews removed a series of dams in the New Hazelton area of the stream, resulting in a major high water event that disrupted fence operations and washed away redds of Pink salmon and early returning Coho spawners. The incident was reported to DFO, resulting in yet another warning to CN. Have any other organizations found a way of getting CN to act in an environmentally responsible manner?
- 2. This is the first time we have encountered a problem with getting timely environmental approval for habitat restoration work from provincial staff. The reason given was 'work overload' and an inability to process the number of applications received. Is this just a problem in our region, or are volunteer organizations in other areas also having problems getting provincial approvals in time to complete funded projects?
- 3. 125 beaver dams on 60 km stretch of river. Different opinions on whether this is an issue to the late run Coho or not...study needs to be done to put this question to a rest. And if they are an issue what do we do about it? Do others have experience?
